This authorization is without respect to the source of any funds in the depository account, and this authority shall remain in full force and effect until Company has received written notification from Client of its termination in such time and in such manner as to afford Company and Depository a reasonable opportunity to act on it. In order to insure that transactions are properly handled, a specimen-voided check is attached.
